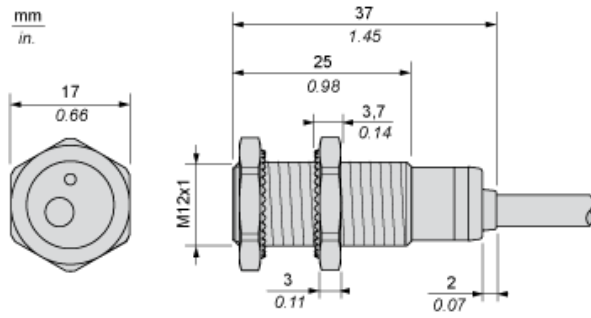

Face to face



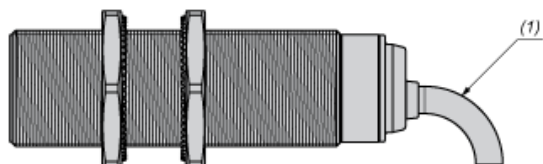
$e (2) \geq 48 \text{ mm}/1.89 \text{ in.}$

Facing a metal object



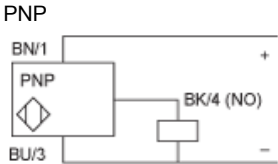
